FEE SCHEDULE (as of JULY 2007)

Standard/Routine Service of Process:

- Service on an INDIVIDUAL – Personal Delivery ONLY: \$150 minimum, \$75 per hour thereafter
- Service on an INDIVIDUAL – Substitute Service O.K.: From \$85 to \$125
- Service on an INDIVIDUAL – ‘Nail & Mail’ O.K.: From \$85 to \$125
- Fees for 2nd Service at same address or on same party: \$35 Each
- Service on a BUSINESS – ‘Any Agent for Service can accept’: From \$85 to \$125
- Service on a BUSINESS – Only Specified Agent can accept: \$150 Minimum, \$75 per hour thereafter
- Unusual/Special Assignments: Per Case to be discussed

EMERGENCY/ RUSH Service of Process:

- Service on an INDIVIDUAL: \$250 minimum, \$100 pr hr thereafter
- Service on a BUSINESS: \$150 minimum
- Expenditures to issue Subpoena Fee checks: \$10 Each

Other Services:

- Mobile New Client Sign-Up (Standard/Non-Rush): \$200 Minimum, \$75 per hour thereafter
- Mobile Witness Statement: \$150 Minimum, \$65 per hour thereafter
- Fee for Locating (Given address invalid) : \$100 per hour + disbursements
- Court Searches, “So Order” Subpoenas, Document Filing, Affidavits and Research: \$75 Minimum, per hour
- Nationwide/International Service: \$150 minimum + disbursements
